COURSE DESCRIPTION

This course should be taken by Schreyer Honors students in Mechanical Engineering, preferably in their junior year. The goal of this course is to provide students with an overview of the research and honors thesis process, as well as general engineering practices and career advice. In this semester, the major deliverable will be the literature review portion of each student's thesis.

Class attendance is required every week. There will be in-class activities in almost every session where we will practice many of the skills necessary to write your thesis. However, we recognize that it may be difficult for students to attend courses for legitimate reasons – illness, family reasons, etc. Please communicate closely with the faculty if you are having issues and we'll work with you to ensure that you can keep up with the course.

Pre-requisite: A thesis supervisor and topic must be identified prior to the start of the course.

Text: "So, you have to write a literature review: a guided workbook for engineers" by Catherine Grace Patrick Berdanier and Joshua Bela Lenart.

ASSIGNMENTS AND GRADING

Pre-class activities: Pre-class activities will be assigned on Canvas in preparation for each seminar period. Students are expected to complete each pre-class activity in preparation for the material that will be covered in class on Wednesdays.

In-class activities: Each class period will have a deliverable due at the end of class. These will be group assignments and will be graded on completeness. These activities are designed to help develop the skills necessary to write an honors thesis.

Thesis-related assignments: Students will be assigned a number of deliverables that relate directly to the thesis. Many of these assignments will require meetings with their thesis supervisors in order to complete

the deliverable. The supervisor will be responsible for helping the students with each of the assignments, and a signature page, signed by the thesis supervisor, will be required as part of each thesis-related assignment.

Grading: Grades will be assigned by the instructors in the course, not the thesis supervisors. As such, assignments will be graded on completeness and quality, not technical accuracy. The rubrics for thesis-related assignments will be published ahead of their due-dates.
